WAIVER OF LIABILITY

I know that there will not be a lifeguard present at this activity and that I am solely responsible for my care and the care of anyone for whom I am parent, guardian or who is under the age of 18 in my care while at this activity. I assume all risk associated with taking part in this activity and gathering at this location (675 Sudbury Road, Concord, MA), both while inside the residence and outside on the grounds, including the use of the pool, those risks including, but not limited to injury, contact with other participants, the effect of the weather, and any other medical events, all such risks being known and appreciated by me. Having read the waiver and knowing these facts and in consideration of your accepting my application, I, for myself, my heirs and anyone entitled to act on my behalf, waive and release John McClellan, Elizabeth Martineau, Nashoba Learning Group, Inc., the Commonwealth of Massachusetts, the town of Concord and any and all other individuals or organizations assisting at the event, and all sponsors, their representatives and successors from all claims of liabilities of any kind arising out of my participation in this activity, even though that liability may arise out of negligence or carelessness on the part of the person named in this waiver.
